PROPOSAL No. 1 - APPROVAL OF THE APPOINTMENT OF DAMIANA MENEGHETTI AS EXECUTIVE BOARD MEMBER REPRESENTING ACT COMMODITIES GROUP B.V. ("ACT") IN THE INDUSTRY, TRADE AND FINANCE CONSTITUENCY UNTIL THE ELECTION OF EXECUTIVE BOARD MEMBERS TO BE CARRIED OUT IN 2022 TO FILL IN THE VACANT POSITION RESULTING FROM JORN JASPER SCHOUTEN'S RESIGNATION.
